



Keep It Clear!

Recently we have had an uptick in reports of material and parts being left in PIV and pedestrian walkways. Per OSHA and many past complaints we've had, the company is supposed to maintain aisles that are free and clear from obstructions. A site wide communication was recently sent out reminding everyone not to store parts, material, chip barrels, pallets, or other equipment in the aisle. All

spills on the floor or aisle should be reported immediately, to be cleaned up. If you are bringing something to an area and no space exists to drop it off, contact management of the area on where to leave items. All aisles have an owner who will be responsible for maintaining clear paths of egress.







PIV Safety and Security

With the multiple projects around the shop and the increase of things being stored in the aisle some Powered Industrial Vehicle (PIV) reminders seemed appropriate. Pedestrians should always stop look and listen before stepping out into aisleway, use the bubble mirrors to see around difficult corners, check for blue lights on fork trucks, and always use designated walkways and crosswalks.

On the other side of the steering wheel, PIV drivers should always watch for pedestrians, come to complete stop and sound horn at all stop signs and crosswalks, and never use headphones, cell phones, or other electronic devices while operating. If you must leave a PIV be sure to engage the brake, lower the forks and remove the key.

Whether on or off the fork truck we all can do our part to stay safe around PIVs.

Project Update

Last month a site wide notice went out for a project in E Lot that would affect 15 parking spots. That project was delayed due to inclement weather and is going to be attempted at a later date. Watch for the site wide communication when that project will begin.

March also brought another wood block replacement in the P aisle of 220. This project is scheduled to take place in 2 phases and should be completed by the start of April. Extra care has been taken to mitigate the dust complaints we received when working the J aisle project. As always, report any issues with this project to your Safety Representative immediately.




